**Sub:- E-Payment of Customs Duty- reg.**

Attention of the importers, trade and their agents is invited to the above cited subject.

1. The E-Payment facility at Customs locations has been functioning since 2007. Recently, with the concurrence of the Pr. CCA, 17 scheduled banks have been authorized to collect Customs duties through e-payment procedure at all EDI locations. Accordingly, the facility to enable a choice of any of the 17 banks at each customs linking bank for effecting Customs Duty had been made available at ICEGATE and this was made operational w.e.f. 16<sup>th</sup> January 2012. In fact, as trade facilitation measure importers of all ports would be able to use any of the 17 Authorized Banks as enumerated below for e-payment.

2. The data of usage suggests that E- payment facility has been well received by the trade. In the first fortnight itself there has been over 33% increase in the number of e-payment transaction on all India basis. It has been decided to start mandatory E-payment procedure as envisaged in Board's circular no 33/2011 dated 29.7.2011 for customs duty payments above Rs. 1 Lac both at ICD,TKD, & ICD, PPG, New Delhi with effect from 21.02.2012.
