

**ELIGIBILITY CRITERIA FOR COMPREHENSIVE ANNUAL SUPPLY OF ONE TIME
LOCKS (SEAL)**

1. The company/firm/enterprise intending to submit the Tender (hereinafter called the bidder) shall be a reputed organization in the field of One Time Lock manufacturing for the last 5 years.
2. The bidder must be undertaking the Supply for at least three Central Government Department/Public Sector Unit (PSU), in any of the previous three years.
3. The bidder's contract should not be terminated before the expiry of the full term, in any previous years or current year.
4. The bidder should have filed IT returns for the last 2 years. Copies of the same shall be submitted along with the bid.

The bidders shall give the proof of above criteria (1), (2) and (3) and an undertaking regarding (4) above.
